

RELEASE AND INDEMNITY AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

1. I hereby acknowledge the educational, recreational, and/or personal benefits accruing to my minor child

by reason of his/her voluntary participation in multimedia workshops to be conducted by the Computer Science Department of The University of Alabama in Huntsville from 8:00 a.m. – 12:00 noon on June 2 and June 3, 2011 (herein, the "Workshops"). I understand that these workshops will utilize the multimedia laboratory in Room S305, Technology Hall, on the University's campus where students may capture videos, create their own multimedia presentations, experience color models, perform basic video editing, and visualize green screen effect. Students may also see applications of multimedia technology by watching video presentations (or movies) and behind-the-scenes activities related to famous movies. In addition, students may develop project management and teamwork skills related to the creation of multimedia presentations and may have the opportunity to capture video in the parking lot adjacent to Technology Hall and other locations on the campus.

2. I do hereby, in consideration of such benefits and other good and valuable consideration, release absolutely, forever discharge, and covenant not to sue The Board of Trustees of The University of Alabama and the officers, employees, and agents of the said Board and/or any of its constituent institutions from and concerning all liability, losses, claims, demands, actions, debts, and expenses of every name and nature for personal and bodily injury (including any resulting in death) or other damages which my minor child may sustain from whatever cause during, arising out of, or as a result of participation in the Workshops or any activity connected therewith, including without limitation the use of any vehicle, or other conveyance or means of transportation, and excepting only wanton or intentional misconduct by the foregoing parties or any of them. It is my intention to include the negligence of the foregoing parties or any of them within the scope of this release/indemnity agreement and to except, by express limitation here stated, only wanton or willful misconduct by the same.

3. I do further hereby expressly, knowingly, and voluntarily assume all risk of personal or bodily injury to my minor child from hazards normally incident to, ordinarily associated with, or reasonably foreseeable from such participation in the Workshops.

4. I further agree to indemnify the foregoing parties against any liability or loss sustained by any of them arising out of my minor child's participation in the Workshops.

5. I do further give my consent and permission for, and waive and/or assign any and all rights to, any photographs or videos taken by The University of Alabama in Huntsville of my minor child participating in and about the Workshops. As exclusive owner of such photographs and/or video tapes and all proprietary and copyright interests therein, The University of Alabama in Huntsville shall have the sole and exclusive right to control and determine the use, display, performance, reproduction, and dissemination of any such photographs and/or video tapes, including copies.

6. I understand that my minor child may be allowed to keep a copy of the video media or multimedia produced by me during the Workshops. I hereby give my consent and permission for the University to make a copy of any such media or multimedia. I hereby grant the University a license entitling it to unlimited use of those copies and any copies of those copies in perpetuity without charge for whatever educational and/or student recruiting purposes it may choose.
